SINGLES ENTRIES

All players are required to complete and submit the entry form by the due deadline (19 September). **No** player may arrive on site and expect to compete without having completed and submitted the entry form by the due deadline and having paid their entry fee in advance.

MAIN DRAW SINGLES EVENT

The Main Draw is scheduled to commence on Sunday 23 October 2005. All players **must** be available to play on this date **if required**. Players must note that if they receive a bye in the first round they may not be required on the first scheduled day. Every effort will be made to avoid requiring a Super-Seniors World Team Championship Competitor to play on Sunday 23 October, but this cannot be guaranteed.

1. agree to encourage and maintain high standards of conduct, fair play and good sportsmanship, and to avoid any acts which may be considered detrimental to the game of tennis. I am aware that the Event shall take place in accordance with the Seniors Regulations 2005, the Seniors Circuit Code of Conduct, the Constitution of ITF Limited and the Rules of Tennis adopted by the ITF. In submitting my entry into the Event I undertake to abide by and fulfil all my obligations under the above-mentioned Rules and Regulations. I also agree to co-operate in good faith with others and to respect playing rules and schedules and, to the extent applicable, travel arrangements and accommodation;
2. agree and consent to my performance or appearance in the Event being photographed, filmed and/or recorded in any medium, and that such stills, film or recording in whole or in part may at your absolute discretion be incorporated in any form of television transmission, publication, film and videogram, or other electronic media of whatever nature now or hereafter invented throughout the world in perpetuity, and consent to the reproduction and use of my name, voice, likeness, performance or biographical details for the purposes of advertising, publicity or otherwise in relation to the exploitation of such film or recording, and the promotion of the Event and the commercial rights thereto;
3. agree that you shall be entitled at any time to assign or licence the whole or any part of the benefit of this Release to any third party.
4. agree in submitting an entry form into the Event I agree, as a condition of entry, that for myself and my executors, administrators, heirs and personal representatives, all claims of any kind, nature and description are waived, including past, present or future claims and injuries if any sustained in travelling to or from or participating in the Event, against the ITF, the host venue, its officers and Volunteers, the Regional Association or National Association sanctioning this event.

RULES & CONDITIONS

REFEREE: Javier Sansierra

ENTRY DEADLINE: Monday 19 September 2005 (date as postmark)

1. EVENTS AND ENTRIES

- a. **Championship Events:** MEN: 60, 65, 70, 75, 80, 85 (singles and doubles)
WOMEN: 60, 65, 70, 75, 80 (singles and doubles)
Minimum 8 participants in Singles and 8 participants or 4 pairs in Doubles

All age categories will be played on red clay.

- b. **Entry Deadline:** The entry deadline will be strictly applied to all non-team Competitors, without exception. The ITF reserves the right to accept an entry from a team Competitor after the entry deadline, but only in exceptional circumstances.
- c. **Eligibility:** Only those players whose National Association is affiliated to the ITF and who have reached, or will have reached, the minimum age limit of the category entered on or before 31 December 2005, shall be eligible to compete.
Passports showing name, nationality and date of birth will be requested on site by the ITF.
- d. **Qualifying:** Should the number of entries exceed the number of places in the Draw, a qualifying event shall be held for Turkish national players only. Players will be advised by letter or email (to the address indicated on their entry form) if they are required to participate in qualifying.
- e. **Doubles Entries:** Players entering **doubles only** must still complete the entry form and send it with the entry fee by the entry deadline date (19 September 2005). **All** doubles entries must be reconfirmed by signing-in on site. **Doubles sign-in deadline: Monday 24 October 2005 at 2.00 pm.** Both members of a doubles team are expected to sign in. **ENTRANTS WHO DO NOT RECONFIRM THEIR ENTRY BY SIGNING-IN ON SITE SHALL NOT BE INCLUDED IN THE DOUBLES DRAW.**
- f. **Accreditation:** The accreditation desk will be open daily from 9.00 am until 4.00 pm from Friday 21 October 2005 until Monday 24 October 2005. All players are required to register.
- g. **Consolation Event:** At the discretion of the Referee, consolation events for first match singles losers shall be held. A decision regarding the staging of consolation events shall be made by the Referee no later than the evening of the second day's play in each Championships singles event.

2. ENTRY FEE

- a. Entries will NOT be accepted without the entry fee of **US\$125 (£68 or €99)** which is payable **per person** whether for entry into singles AND doubles or singles OR doubles ONLY.
- Methods of payment
 - Credit Card (see enclosure – please note amounts will be deducted in UK £ Sterling);
 - Cash (US\$, UK £ Sterling or €Euro)
 - Cheque drawn on a US or UK bank or on a bank within the “Euro zone”Cheques should be made payable to **“ITF Ltd”**.

- b. Refunds:** Refunds in full will be made if withdrawal is notified at least seven (7) days before the start of the tournament's main draw. All withdrawals must be made in writing, by facsimile or by email. If withdrawal is notified within seven (7) days of the start of the tournament's main draw, refunds will only be made for reasons of health, injury or bereavement.

3. COURTS AND MATCHPLAY

a) Match Courts:

Club Ali Bey Manavgat: 56 red clay courts

- b) Practice Courts:** Practice courts will be available at the venue from Friday 21 October 2005. During the event, practice courts will be available throughout at the venue.
- c) Balls: Völkl.** A minimum of three new balls will be provided for the first two sets. New balls will be provided for any third set. Practice balls will also be provided in accordance with the Regulations.
- d) Code of Conduct:** The Competition will take place in accordance with the Rules of Tennis, the Rules of the ITF, which includes the Regulations for the ITF Super-Seniors World Championships and the Seniors Code of Conduct as stated in the ITF Seniors Regulations 2005.
- e) Undertaking:** Unless otherwise advised, each entrant undertakes to remain on site and ready to play until the scheduled date for the completion of the event(s) in which that person has entered or until elimination.
- f) Players:** All players are required to report to the "Match Control Centre" desk **15 minutes** before the scheduled time of their match. A player who is not ready to play 15 minutes after being called may be defaulted.
- g) Dress on Court:** During a Match, players must be dressed in acceptable tennis attire in accordance with the ITF Seniors Code of Conduct on "Clothing".
- h) The Draw:** The Draw will be made by the Tournament Committee, in consultation with the Referee and the ITF Representatives on Friday 21 October 2005.
- i) Seeding:** Seeding will be determined by the ITF Seniors Seeding Committee.
- j) Times of Play:** Play will commence at 9.00 am, or as otherwise decided by the Referee. All players **MUST** be available for play from Sunday 23 October until Sunday 30 October 2005. Every effort will be made to avoid requiring Super-Seniors World Team Championships Competitors to play on Sunday 23 October; however, this cannot be guaranteed.
- k) Matches:** All matches will be the best of 3 tie-break sets. In the men's 85 and women's 75 and 80 events, should the score reach one set all, one (1) ten (10) point tie break game only shall be played to determine the winner.

l) Rest: A 10 minute rest may be taken after the 2nd set in all events.

- m) Officiating:** Chair umpires will be provided for all Main Draw finals matches – singles and doubles. In the previous rounds, players should be prepared to officiate for themselves.

4. SUNDRY MATTERS

- a) **Accommodation:** Competitors and accompanying persons are requested to make their accommodation arrangements direct with the official hotel. Full instructions and details are enclosed.

Club Ali Bey is a tennis hotel resort. All players can be accommodated on site in the guesthouses benefiting from full access to the beach, aqua park, gym, swimming pools and children's crèche at no extra charge. Sauna and Turkish bath are available for a small fee. There are 5 on site restaurants at Club Ali Bey Manavgat.

- b) **Opening ceremony:** All players are requested to attend the Opening Ceremony on Sunday 23 October 2005 at Club Ali Bey Manavgat, at 4pm. Players are requested to wear their official team clothing, national tracksuit or uniform.
- c) **Functions:** Welcome Cocktail (Sunday 23 October at Club Ali Bey Manavgat, immediately after the Opening Ceremony) and the Gala Dinner (Wednesday 26 October, at 7pm at Club Ali Bey Manavgat beach restaurant). (Free of charge to all competitors and accompanying persons staying in official accommodation.)
- d) **Transportation:** Antalya International airport is approximately 75 kilometres from the venue. All players lodging at Club Ali Bey will be met from Antalya International Airport from Friday 21 October – Sunday 23 October 2005, free of charge, provided that advance notification of arrival times is supplied.

The pick-up service from the airport operates several times a day.
Times : 10.30am, 1pm, 4pm, 8.30pm, 11.30pm, 1.30am.

Please complete and return the attached arrival form to Ms Suzan Kaygisiz by Monday 3 October. If required, players will be returned to Antalya International Airport for a period of 24 hours following the conclusion of the event.

- e) **Medical Recommendations:** Players are responsible for checking with their local health authority regarding medical recommendations for travel to the country hosting the ITF Super-Seniors World Championships.
- f) **Hospitality:** All Main Draw Championships Singles players reaching the final and semi-final of their respective event will receive the following hospitality payments: winner US \$600 per person, runner-up US \$400, semi-finalists US \$250 per person, such amounts to be paid in cash on site by the ITF, following the prize giving ceremony.
- g) **Medals:** Medals will be presented to the players as follows:
Winners of singles and doubles events – Gold
Finalists in singles and doubles events – Silver
Semi finalists in singles and doubles events – Bronze
3rd / 4th place play off matches will not be played in either Singles or Doubles. All semi finalists will receive a bronze medal.

ACCOMMODATION

The ITF recommends the under-mentioned hotel as the official hotel for the ITF Super-Seniors World Individual Championships.
